AN ORDINANCE TO AMEND THE YORK CHARTER TOWNSHIP TRUCK ROUTE ORDINANCE, BEING ORDINANCE NO. 75, PURSUANT TO AUTHORITY IN SECTION 726 OF THE MICHIGAN VEHICLE CODE, BEING MCL§257.726, BY ADDING A PORTION OF RIDGE ROAD TO THE LIST OF APPROVED TRUCK ROUTES IN THE TOWNSHIP.

THE CHARTER TOWNSHIP OF YORK WASHTENAW COUNTY, MICHIGAN ORDAINS:

Section 1. AMENDMENT TO ORDINANCE NO. 75. Section 4 of the York Charter Township Truck Route Ordinance entitled Commercial Truck Routes within York Charter Township, is hereby amended by adding Ridge Road between Hack Road and Mooreville Road as a designated commercial truck route in the Township. Except as otherwise provided for herein, the remainder of Ordinance No. 75, as amended, is hereby affirmed and continued in full force. The commercial truck routes, as amended by this Ordinance, are shown on attached revised truck route map.

Section 2. EFFECTIVE DATE; PUBLICATION. The Township Clerk shall cause this Ordinance to be published in the manner required by law. This Ordinance shall be effective as of the date of final publication of the Ordinance. This Ordinance was duly adopted by the York Charter Township Board at its regular meeting called and held on the 12th day of March, 2019 and was ordered given publication in the manner required by law.
