AN ORDINANCE TO AMEND ORDINANCE NO. 65, THE ZONING ORDINANCE OF THE CHARTER TOWNSHIP OF YORK, PURSUANT TO AUTHORITY GRANTED UNDER P.A. 110 OF 2006, BEING MCL §125.3101, ET. SEQ., AS AMENDED.

THE CHARTER TOWNSHIP OF YORK, WASHTENAW COUNTY, MICHIGAN, HEREBY ORDAINS:

SECTION 1 - AMENDMENTS, ADDITIONS, AND DELETIONS.

Section 20.02 of the York Charter Township Zoning Ordinance, the Table of Permitted Uses by District, is amended by providing that a Child or Adult Day Care Center is a special use in zoned Conservation Preservation (CP) districts in the Township. The letter S is hereby added in the box found in the Table of Permitted Uses, Section 20.02 of Ordinance No. 65, under the column for Conservation Preservation, in the row under Office, Service, and Community uses where Day Care Center, Child or Adult, appears as a listed use.

SECTION II - SEVERABILITY

If any section, subsection, subparagraph, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof, or of any other provisions in the Charter Township of York Zoning Ordinance.

SECTION III - REPEAL

All ordinances or parts of ordinances in conflict with this are hereby repealed.

SECTION IV - SAVINGS CLAUSE

The balance of the York Charter Township Zoning Ordinance, except as herein or heretofore amended, shall remain in full force and effect. The amendment provided herein shall not abrogate or affect any offense or act committed or done, or any penalty or forfeiture incurred, or any pending fee, assessments, litigation or prosecution of any right established, occurring prior to the effective date hereof.

SECTION V - PUBLICATION AND EFFECTIVE DATE

The Township Clerk shall cause this Ordinance to be published in the manner required by law. This Ordinance shall be effective on the 8th day after final publication of the Ordinance.
